## Overview

California Water Service (Cal Water) serves about 2 million Californians in more than 110 communities, from Chico in the north to the Palos Verdes Peninsula in the south, including residents and businesses in **Assembly District 3**. We are the second-largest retail water provider in the state, and the largest regulated by the California Public Utilities Commission.

**We believe everyone should have access to water that is safe, clean, reliable, and affordable.** Providing this for our customers requires a proactive commitment to infrastructure investment, water quality, conservation, community safety, and equity.

### We are Industry Leaders in:

- **Water Quality:** Our drinking water is among the safest in the nation.
